Legal Descriptions for Release of Easement om April Ridge 4th Addition. April 29, 2020

Legal Description for Easement Release Area 1

That part of the 45.00 foot wide drainage and utility easement within Lot 4, Block 1, April Ridge 4th Addition, according to the recorded plat thereof, Anoka County, Minnesota, described as follows:

Commencing at the northeast corner of 100th Avenue NE as depicted on said April Ridge 4th Addition; Thence northerly along the east line of said Lot 4 for 77.95 feet, more or less, to the south line of the North 85.00 feet of said Lot 4;

Thence deflect to the right 90 degrees 00 minutes 00 seconds 21.00 feet to the point of beginning; Thence deflect to the right 90 degrees 00 minutes 00 seconds 130.00 feet; deflect to the left 90 degrees 00 minutes 00 seconds 24.00 feet to the easterly line of the above described 45.00 foot wide drainage and utility easement;

deflect to the left 90 degrees 00 minutes 00 seconds, along the last described easterly line, 130.00 feet; Thence deflect to the left 90 degrees 00 minutes 00 seconds 24.00 feet to the point of beginning.

The South 5.00 feet of the North 90.00 feet of the West 50.00 feet of the East 95.00 feet of Lot 4, Block 1, April Ridge 4th Addition, according to the recorded plat thereof, Anoka County, Minnesota.
