Hello Mayor Ryan and Blaine City Councilmembers,

Greetings. My name is Jane Schneider and I am a 19 year Blaine resident. I've been in my current house in the Pleasure Creek neighborhood since 2001 (you may remember our neighborhood from the 2005 Blaine tornado). I am writing to you this morning to voice my opposition to the proposed 200 Unit Apartment Complex located on 117th Avenue/ Ulysses Street.

Impact on Schools

As you know - the population boom in Blaine has created a huge impact on the schools - especially in the Anoka Hennepin District. With the current proposed boundary changes, new school yet to be completed and the significant over crowding at Blaine High School, I can't imagine what adding 200 units would do to an already burdened situation. My daughter is a freshman at BHS and the overcrowding is a significant concern that has adversely impacted her ability to obtain a seat to eat her lunch. I really would like the impact on schools to be factored into this decision not to move forward with this project.

Impact on the Roads

109th and 65 is continuing to be a dangerous intersection - in all directions. Just this morning - I had to wait three light cycles to cross from the west side to the east side of 65. During that time, I saw countless careless behavior in an effort to make the light. Ulysses is extremely busy, especially with a park and ride north of this proposed project. I would like to see all residential projects - especially medium or high density residential projects placed on hold until the state completes their assessment of the intersection to come up with a solution to our current traffic challenges. With a proposed townhome development of the old Be Bop land on 109th, I don't see how we can absorb more cars in that area. I think the quality of life for the current residents would be significantly impacted if the council approves this project.

Quality of Life on the West Side of Blaine

I would like to see better projects on the West Side of Blaine other than a medium density apartment complex. I am trying to not be insulting, however when I think of this project - I think of the Springbrook Apartments in Fridley. I just can't imagine anyone wanting to live in an apartment building behind a Wal-Mart.

As many of you are already are aware, there is a disparity between the two sides of Blaine (Blaine-tucky verses Blainedina). It has recently been displayed by the parents on the East Side opposing sending their students to Northdale Middle School due to it's location in Coon Rapids. With this impression already in place, it's bad enough the West Side has that atrocious Wal-Mart but now the idea of putting apartments (no matter their price point) is just a bad idea. I want to retain my property values and I feel that projects like this will adversely impact the value of my house - something I never would have imagined when I built my house in 2001. I personally like many of the current projects along Ulysses which are medical buildings as their traffic is during the week day.

I would like the city council to factor in all these points I just made to ultimately deny approval of this project.

I thank you for considering my thoughts on this concerning issue. I hope to attend the City Council meeting on April 9th to further discuss.

Okay. I don't mind them building up the area. I just worry about the traffic the new apartments will bring. More cars mean the roads get replaced more often and that is costly to those that live on 117th not to the general public. Semi go down 117th and they shouldn't. A million buses do. Every car/truck that lives in the area, plus all the people using 117th to cut across because it doesn't have the lights 109th or Main Street do. More traffic, means more wear and tear on the road. They pull up the road to redo it, that shuts my in-home preschool down because no one can get here unless they park a few blocks away and walk. I had to get State Senators involved last time they repaved the road. 117th went from a local road and over the last 15 years really turned into a collector road and I don't want to see it turned into an arterial road in the next 15 years. People already sell house on this road left and right. The turn around is crazy.

It's also a concern for safety. The people on 117th have been fighting the city for 7 years now about 117th and the traffic. They had a petition and everything back in 2011 about it and a few meetings with council members and we were told too bad too sad live with it pretty much. But one of these days someone is going to die again on 117th because of all the speeders and people blowing the stop signs. Not excited about even more traffic on the road now. There are at least 4 different schools with bus stops on 117th and you have walkers going to and from Jefferson Elementary that cross over 117th twice a day. I was glad when my daughter's school moved their bus stop to be in a local parking lot and not on 117th anymore.

Two years ago, some kids almost got killed by a UPS truck that didn't stop at a stop sign on 117th and all they were doing is coming home from school. People already speed down this street like it's Main Street or something and all the stop signs seem to be options between 65 and University to

some cars. No surprise people in the area are concern about more traffic to their neighborhood. People had concerns when the Lowes and that whole area got built up. They had concerns when the Medical Center and Walmart went in. All those things are nice and help Blaine. But most people using them aren't the ones that have to live there day after day and deal with it 24/7. When traffic is bad, it can take you up to 5 minutes just to pull out of your own driveway – no joke. There are times you can't get to your mailbox because it's not safe to step on into a busy street to check your mail. Shoveling the end of your driveway is dicey at times because of all the cars especially during morning and evening rush hour. It wasn't like this when I brought my house on this road, it's part of the reason we want to leave so badly. So I can see people getting upset. But you know change is going to happen.

Hopefully, they have a plan in place for all the extra traffic to that area because that stop sign isn't going to cut it at that point. It's not working great as it is right now. More traffic is just going to back things up on 117th and on Ulysses even more at that meeting point. So, we will see what will happen.

I encourage you to recommend denial of Public Hearing Case File No. 18-0006. I believe the zoning and land use should remain as MDR medium density residential and the site used for townhomes. The area is already heavily congested and with the new businesses coming into the area it will only get worse. Due to Hwy65 being so congested along with the intersection of 109th/Ulysses, 117th Avenue will be the primary route used by the apartment occupants and that is very dangerous with 117th Avenue being a residential 30 MPH street. There are many kids in the area not to mention bus stops all along it. 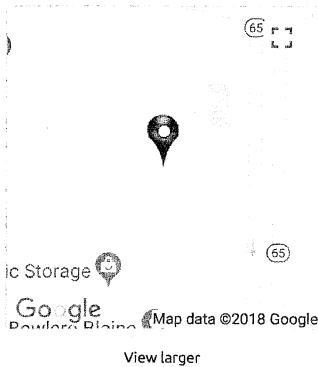

Item 4.10 - 117th Avenue/Ulysses St Apartments

Members of the Planning Commission:

As the residents of 950 117th Avenue NE we have strong objections to the proposed apartment buildings at 117th Avenue and Ulysses Street and would like to see the property remain zoned for townhomes.

According to the proposed plans there will be an entrance and exit from 117th Avenue. In looking at some of the larger apartment complexes in Blaine they enter and exit off a service road and not a residential 30 mph road that has driveways, school bus stops and trail access along it. Examples include:

- Crestview – Ulysses Street (service road)
- Emberwood – Ulysses Street (service road)
- The Parkway Off Central – Ulysses Street (service road)

Attached is a police report of traffic citations issued on 117th Avenue over the past year. Putting two apartment complexes with 200 units into the area would most certainly worsen the problem. In speaking with one of the police officers he compared running radar along 117th Avenue to “fishing in a gold fish pond”.

Below is chart showing trips per day that will be generated (according to industry standards). Keeping the property zoned for townhomes and not apartments would generate 720 less trips a day (based on estimated # of units).

Vehicle Trips Generated Per Day – Industry Standard

Single Family	10	30 (estimate)	300
Townhome Unit	8	60 (estimate)	240
Apartment Unit	6	200 (proposed)	1,200

While the proximity to TH65 is very close, these residents will quickly learn how horrendous traffic on TH65 is and find alternative routes – a popular one being 117th Avenue to University Avenue. It is our belief that anyone commuting to the west will travel 117th Avenue to University to 610 as the intersection of 109th Avenue and Ulysses Street is also very heavily congested.

We encourage you to recommend denial of the land use change and rezoning to allow for apartment complexes.

As an alternative, we would recommend eliminating the access point to the apartment complex on 117th Avenue. There are many complexes that only have one access or their access is only onto one road, several recently approved. Examples include:

- Emberwood (112 units) – Ulysses Street only access
- The Parkway Off Central (191 units) – Ulysses Street only access
- Blaine Town Square (87 units) – 108th Lane only access
- Crestview (assisted and memory care) – Ulysses Street only access

Thank you for taking my concerns along with my neighbors into consideration when making your recommendation to City Council.
