PROPOSED DESCRITION TO VACATE DRAINAGE AND UTILITY EASEMENTS

A 5.00 foot wide easement for drainage and utility purposes lying over, under and across Outlot A, CHAIN OF LAKES ADDITION, according to the recorded plat thereof, Anoka County, Minnesota, as delineated and dedicated on said plat. The east line of said 5.00 foot wide easement is described as follows:

Beginning at the southeast corner of said Outlot A; thence on an assumed bearing of North 00 degrees 57 minutes 34 seconds East, along the east line of said Outlot A, a distance of 158.00 feet, to an angle point in said east line; thence South 89 degrees 02 minutes 26 seconds East, along said east line, a distance of 11.50 feet, to an angle point in said east line; thence North 00 degrees 57 minutes 34 seconds East, a distance of 134.50 feet, to an angle point in said east line; thence North 89 degrees 02 minutes 26 seconds West, along said east line, a distance of 17.00 feet, to an angle point in said east line; thence North 00 degrees 57 minutes 34 seconds East, a distance of 231.99 feet, to the north line of said Outlot A and there terminating.

Except those parts thereof lying within the northerly and southerly 10.00 feet of said Outlot A.
