7 Previous Business

7.1 Update on June 5, 2018 Open Forum - Resident concerns of Motorcycle Noise on 99th Avenue

The Police Department monitored decibel levels of motorcycles in the area of 99th Ave on July 14 and 15, 2018. The decibel levels ranged from 45 to 81. These numbers are typical of an urban area with traffic noise from TH 65 and the Blaine Airport.

7.2 Resident e-mail on 121st Avenue Striping west of Sunset Avenue

City Council received one complaint on the new striping installed on 121st Avenue west of Sunset Avenue. The double yellow centerline stripes and outside white edge stripes were approved by the Traffic Commission and City Council in response to neighborhood concerns with speeding vehicles. The striping was recommended by the City's Consultant Engineer for Traffic Studies to help reduce speeds in residential areas. The resident that sent the email to Council was concerned that speeds would increase with the striping and he was asked to let the City continue to monitor speeds on 121st Avenue from Woodland Parkway to Sunset Avenue to see if a reduction of speed was achieved.

7.3 Update on November 8, 2017 Open Forum - Resident Concerns of Speeding on 121st Avenue east of Aberdeen Street

The Police Department has been monitoring vehicle speeds in this area. The speed trailer has been placed on 121st Avenue to help with education and enforcement efforts. Speed has not observed to be an issue.

7.4 Resident Complaints of Speeding on Harpers Street North of 125th Avenue

The Police Department have been monitoring vehicle speeds in this area. Over the last year, the traffic count tubes and speed trailer have registered the 85th percentile of speeds from 32 to 35 MPH. The speed trailer has been placed on Harpers Street to help with education and enforcement efforts. The Traffic Unit will continue to monitor speeds in this area.
