## GRANT OF PERMANENT EASEMENT

WITNESSETH, that said Grantors, in consideration of One and No/100 (\$1,00) Dollar to them in hand paid by said Grantee the receipt of which is hereby acknowledged, and other good and valuable consideration, hereby grant to said Grantee, its successors and assigns, the following described easements in perpetuity for utility and drainage purposes, and for ingress and egress at any and all time with all machinery, equipment, and materials necessary for the aforesaid purposes, which easements are described as follows:
