One of the Board's functions is to hold public meetings and make recommendations to the City Council. For each item, the Board will receive reports prepared by City staff, provide the opportunity for public response, conduct Board discussions and make recommendations. The City Council, however, makes all final decisions on these matters.*

##### **NRCB Updates**

Mr. Monahan provided the Commission with updates on the following:

##### **BWS Structure and Concept Trail System Update**

Mr. Monahan stated in May, staff reviewed options with the City Council for a structure at the Blaine Wetland Sanctuary (BWS) parking lot located at 11980 Lexington Avenue. The City Council gave staff direction to move forward with hiring a consultant to design a pavilion with restrooms. Staff also reviewed the 2014 BWS Master Plan trail system concept and discussed the possibility of updating the plan to be more cost effective. The updates would maximize uplands, limit boardwalks, utilize city property in neighborhoods for trail connections, and reduce trails behind homes.

Mr. Monahan reported the City Council gave staff direction to move forward with updating the BWS Trail System Plan. Staff will begin this work once the regulatory agencies approve the trail through the Central and Northern Portion of the BWS.

Boardmember McKinley asked if the trail system would be coordinated to preserve all wetlands. Mr. Monahan reported staff was working with regulatory agencies while updating the proposed trail system within the BWS. He stated the upland areas would be maximized to preserve as much wetlands as possible.

**Volunteer rescue of State endangered Rubus Stipulates at BWS**

Ms. Haug provided an update on the plant rescue event that was held at the BWS on June 10. She reported volunteers were needed to water the replanted plants.

**BWS Appreciation Tour with Anoka Conservation District, CCES, and City of Blaine**

Ms. Haug discussed the BWS Appreciation Tour with the Anoka Conservation District and noted this event was scheduled for August 10 from 5-7PM with a backup date of August 12. She stated more information was to come.

**BWS Ongoing Maintenance**

Ms. Haug explained the spring burn scheduled at the BWS has been delayed due to weather conditions until the fall. The large upland island in the north portion was the only area burned this spring. Additional maintenance throughout the summer will include; spot herbicide treatments, interseeding, and potential threatened and endangered plantings.

**BWS Entrance Sign**

Mr. Monahan stated the city's consultant, SRF, will be putting a bid out late June or early July for the BWS entrance sign. It was noted construction would follow later this fall.

Boardmember McKinley commented on the plans she had created for the existing BWS entrance sign. She asked that she be allowed to keep the existing sign once the new sign was in place.

**MOVED** by Boardmember Panning, seconded by Boardmember Truchon to allow Boardmember McKinley to keep the existing BWS sign once the new entrance sign was in place.

A roll call vote was taken. Motion carried unanimously.

**BWS Summer Programs**

Mr. Monahan explained Parks and Recreation staff is collaborating with Growing Green Hearts and the Wargo Nature Center to provide summer programs at the BWS this summer. Staff reviewed the upcoming programs that were being offered by the City.

**Sunrise Ponds Trail**

Mr. Monahan reported staff is currently working with the consultant, SRF, on design and permitting for the Sunrise Ponds Trail with hopes of getting the bid out in July.

Boardmember Truchon thanked staff for working to save natural open spaces in Blaine. She asked if a trail would be put in place to the Sunrise School. Mr. Krieger stated this was being discussed with the school. Mr. Monahan discussed the sidewalk that was currently in place at Sunrise Ponds that could be accessed by students.

**Pioneer Park Update**

Ms. Haug commented on the discussion staff had with the City Council regarding the Pioneer Park wetland banking from the June 14 City Council Workshop. She indicated the Council would like to have more education and outreach with the public regarding what this project entails.

Boardmember Truchon questioned what would be the best way to advertise the actions that would be taken at Pioneer Park to the public. Ms. Haug stated the extensive tree study could be reviewed with the public and noted staff could also provide tours of the space.

Boardmember Filipi supported the City providing tours of the space. She believed this would provide a great visual for the neighbors to the Pioneer Park area.

Boardmember Truchon recommended the City consider creating a video to be placed on the website for educational purposes.

Mr. Monahan explained the City was proposing to restore 43 of the 100 acres within Pioneer Park. He noted the 43 acres have always been wet and he understood it would be good to get these facts to the public. He discussed how the proposed work would clean up the dead and dying trees.

Chair Perkins suggested flyers be passed out to residents in this neighborhood on Night to Unite. Ms. Haug reported there was a lot of information already available on the City's website regarding this project.

Jason Husveth, SRF, commented on the Pioneer Park project. He explained this park was being considered as a wetland bank and commented on the rare species that had been located within the wetland. He discussed how headwater wetlands have a great potential for being fully restored. He noted this project has been conceptual in nature due to COVID and explained the next phase was the draft mitigation banking instrument. He reported this phase takes approximately one year to complete. He encouraged the City to engage the public and move this project forward.

Chair Perkins thanked Mr. Husveth for his comments.

**MOVED by Boardmember Truchon, seconded by Boardmember McKinley to recommend the City Council move forward with the Pioneer Park wetland banking project by pursuing the draft mitigation banking instrument.**

**A roll call vote was taken. Motion carried unanimously.**

Mr. Monahan stated he has appreciated all of the knowledge he has

gained from Ms. Haug and noted she would be sorely missed. He wished Ms. Haug all the best in her new position.

Mr. Monahan reported he would like to conduct a park tour for the July NRCB meeting. He recommended Pioneer Park and Sunrise Ponds be toured in July. The Board supported this recommendation.
