### **AUTHORIZE TEMPORARY REMOVAL OF PARKING RESTRICTIONS ON 91<sup>ST</sup> AVENUE, 92<sup>ND</sup> AVENUE, 92<sup>ND</sup> LANE AND BALTIMORE STREET TO ACCOMMODATE LETTERMEN SPORTS TENT SALES ON JUNE 3-11 AND JULY 29 -AUG. 6, 2019**

The City of Blaine received a request on April 15, 2019, from Amy Schumacher, representing Lettermen Sports, requesting temporary removal of parking restrictions on 91<sup>st</sup> Avenue, 92<sup>nd</sup> Avenue, 92<sup>nd</sup> Lane and the west side of Baltimore Street in order to allow parking on those streets June 3-11 and July 29 - August 6, 2019. Lettermen Sports is hosting their annual Tent Sale those weekends and expect a need for additional parking to accommodate their customers.

Staff recommends authorization for temporary parking on the west side of Baltimore Street and both sides of the three additional streets as indicated on the attached map.

City Council authorization is required for the temporary lifting of parking restrictions. City Council has previously authorized similar temporary lifting of parking restrictions for Lettermen Sports 2012 - 2018 Tent Sales.

By motion, authorize the temporary removal of parking restrictions on both sides of 92<sup>nd</sup> Avenue cul-de-sac east of Baltimore Street, 91<sup>st</sup> Avenue and 92<sup>nd</sup> Lane between Baltimore and Davenport Streets, and the west side of Baltimore Street between 91<sup>st</sup> Avenue and 92<sup>nd</sup> Lane, from 10:00 AM to 9:00 PM, June 3-11 and July 29 - August 6, 2019.
