APPROVE PLANS AND SPECIFICATIONS AND ORDER ADVERTISEMENT FOR BIDS FOR THE 2021 POLK STREET AREA RECONSTRUCTIONS, IMPROVEMENT PROJECT NO. 19-16

The Public Hearing for the proposed improvement project was held on October 19, 2020, and the City Council ordered the preparation of plans and specifications. The proposed project will reconstruct the following streets:

- **Polk Street** from 89th Avenue to Clover Leaf Parkway
- **Tyler Street** from 89th Avenue to 91st Avenue
- **Van Buren Street** from 89th Avenue to 91st Avenue
- **Jackson Street** from 89th Avenue to 91st Avenue
- **90th Lane** from 91st Avenue to 91st Avenue

Proposed improvements include installation of concrete curb and gutter where not present, replacement of existing curb and gutter on 90th Lane, spot replacement of existing curb and gutter on Polk Street north of 91st Avenue, spot sidewalk replacement, storm drainage improvements, hydrant replacements, asphalt surface replacement, traffic control signage, and appurtenant construction.

Plans and specifications have been prepared as directed and are available for Council review in the Engineering Department.

2. The City Manager shall prepare and cause to be inserted in the official newspaper of the City an advertisement for bid for making of such improvements pursuant to the approved plans and specifications.
3. Such advertisement for bids shall call for sealed bids to be received in compliance with Notice of Contractor for the advertisement for bids.
