### **APPROVE PLANS AND SPECIFICATIONS AND ORDER ADVERTISEMENT FOR BIDS FOR 113<sup>TH</sup> AVENUE TRUNK SANITARY SEWER IMPROVEMENTS, IMPROVEMENT PROJECT NO. 17-09**

The Public Hearing for the proposed improvement project was held on December 7, 2017, and the City Council ordered the preparation of plans and specifications. The proposed improvements will introduce sanitary sewer to the area south of 113<sup>th</sup> Avenue roughly bordered between Quincy Street on the west and Buchanan Street on the east. The project area includes commercial property adjacent to 109<sup>th</sup> Avenue between Able Street and Fillmore Street. The proposed improvements include trunk sanitary sewer and appurtenant construction. Council authorized Carlson McCain to prepare plans and specifications on January 18, 2018.
