The City received a petition dated June 20, 2019 from Tyler Edwards, representing Menard, Inc., requesting the vacation of drainage and utility easement on Outlot D, National Market Center. Stormwater features covered by the easements are being relocated. The applicant represents a 100% of the affected property abutting this easement.
