### ADOPT 2018 CHARITABLE GAMBLING FUND BUDGET

Staff presented a proposed 2018 Charitable Gambling Fund Budget for discussion at the September 21, 2017 Council Workshop where Council reviewed the proposed budget and the estimated fund reserves. Pursuant to Council direction following the September Workshop, staff has appropriated funding for 2018 for those organizations listed below. A summary of the budget is as follows:

- Total Revenue budgeted for 2018 equals \$131,000, an \$11,000 decrease compared to the 2017 Adopted Budget.
- Total expenditures equal \$142,500. Specific allocations for each year are as follows:
