Michael Huey, applicant for St. Timothy's Catholic Church, has filed an application for a Temporary On-Sale 3.2% Malt Beverage license and James Waknitz, owner of Mad Jax Amusements, has submitted an application to hold a carnival at St. Timothy's Carnival to be held at 707 - 89<sup>th</sup> Avenue NE for the following dates and times:

Friday, September 9, 2016 5:00 p.m. - 10:00 p.m.

> Saturday, September 10, 2016 11:00 a.m. - 10:00 p.m.

Sunday, September 11, 2016 11:00 a.m. - 4:30 p.m.

Mr. Huey has deposited with the City a \$50 license fee and a certificate of insurance (liquor liability) covering this event. The City has been named as an additional insured on the certificate of insurance.

Mr. Waknitz has deposited a \$300 license fee and a certificate of insurance naming the City of Blaine as an additional insured.

Background checks for Mr. Huey and Mr. Waknitz have been completed by the Police Department and no problems or complaints are on file. An inspection will be completed by the File #: MO 16-081, Version: 1

Approximately 3,000 people are expected to attend the event.
