AMENDING APPENDIX D - FEE SCHEDULE OF THE BLAINE CODE OF ORDINANCES REGARDING ARTICLE XI. - STORMWATER MANAGEMENT, DIVISION 3. - SPECIFIC USE OF STORMWATER PONDS - SEC. 34-523. -STORMWATER POND AERATION PERMIT

Staff is requesting establishing a fee for the Stormwater Pond Aeration Permit adopted August 4, 2016. First reading was held on September 1 and is being presented at this time for adoption.
