SECOND READING

AMENDING SECTIONS 30.14 AND 30.24 OF THE ZONING ORDINANCE OF THE CITY OF BLAINE TO AMEND RESTRICTIONS FOR CAR RENTAL AGENCY AS A CONDITIONAL USE IN THE B-2 AND B-3 ZONING DISTRICTS. CITY OF BLAINE. (CASE FILE NO. 18-0033/BKS)

The Planning Commission voted unanimously to approve the proposed code amendment. There were no comments at the public hearing.

The B-2 and B-3 zoning chapters both allow smaller scale Vehicle Rental Agencies to be located in those districts but limits their location by requiring them to be part of or on the same parcel as an automotive repair or vehicle sales lot. Recently the City Council discussed this

issue and suggested that the B-2 and B-3 code could allow this use throughout the district and not require car rental to be part of another automotive repair or vehicle sales use.

The proposed code amendment addresses this issue by simply removing the language requiring the connection or association with an auto repair or vehicle sales use. The amendment also cleans up language regarding the number of vehicles allowed on site.

Code Amendment

THE CITY OF BLAINE DOES ORDAIN: (Added portions are underscored and deleted portions are shown in brackets with overstrike.)

30.14 B-2 Conditional Uses

(y) Vehicle Rental Agency with [between two (2) and] up to fifteen (15) vehicles on site. [Must be located on the same property with an approved Major Automobile Repair.]

30.24 B-3 Conditional Uses

(gg) Vehicle Rental Agency with [between two (2) and] <u>up to</u> fifteen (15) vehicles <u>on site.</u> [Must be located on the same property with an approved Major Automobile Repair or Vehicle Sales Lot.]
