ADOPT THE 2019 GENERAL FUND BUDGET

Council conducted a public hearing for the proposed 2019 General Fund budget and proposed property tax levy on December 13. Pursuant to statutory requirements, a public hearing is again scheduled for tonight at which the City Council will consider public input and adopt a final levy and budget.

The attached resolution reflects adjustments made since the December 13 public hearing, and is recommended for adoption.

WHEREAS, the City Council has, after due consideration and deliberation, made such amendments and adjustments in the proposed General Fund Budget as they consider necessary, desirable, or expedient.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Blaine as follows:

- 1. That the proposed General Fund Budget shown below is approved.
- 2. That the 2019 budget appropriations shown below are approved.
- **3.** That the City Manager is authorized and directed to implement and to administer, within the budgetary funding limits and within adopted City policy and relevant State and City laws and regulations, said approved General Fund Budget.
