### **ACCEPT BID FROM PARK CONSTRUCTION COMPANY IN THE AMOUNT OF \$3,281,593.49 FOR THE LEVER STREET AREA STREET RECONSTRUCTIONS, IMPROVEMENT PROJECT NO. 18-16**

Bids were received at 10:00 AM, May 14, 2019, for the Lever Street Area Street Reconstructions, Project No. 18-16. A total of 4 bids were received ranging from \$3,281,593.49 to \$3,791,492.21. The Engineer's estimate for construction and three lowest bidders are as follows:

Engineer's Estimate - Construction Cost	\$2,963,000.00
Park Construction Company	\$3,281,593.49
Dresel Contracting, Inc.	\$3,569,479.08
Forest Lake Contracting, Inc.	\$3,699,260.26

Bids have been checked and tabulated, and it has been determined that Park Construction Company of Minneapolis, Minnesota is the lowest bidder. The Engineering Department has worked with Park Construction Company on previous contracts. Staff recommends the low bid be accepted and a contract entered into with Park Construction Company.

City Council is also asked to approve a 10% contingency to bring the total project budget to \$3,609,753.00. The funding source for this project is assessments, Municipal State Aid funds, Public Utility funds and the City Pavement Management Program fund, and there are sufficient funds to cover these costs.

By motion, adopt the resolution.

**WHEREAS**, pursuant to advertisement for bids for Improvement Project No. 18-16, said bids were received on May 14, 2019, opened and tabulated according to law, and the following three lowest bids were received complying with the advertisement:

Park Construction Company	\$3,281,593.49
Dresel Contracting, Inc.	\$3,569,479.08
Forest Lake Contracting, Inc.	\$3,699,260.26

**AND WHEREAS**, Park Construction Company of Minneapolis, Minnesota is the lowest responsible bidder.

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Blaine as follows:

1. The Mayor and City Manager are hereby authorized and directed to enter into a contract with Park Construction Company for the designated improvements in the amount of \$3,281,593.49.
2. A 10% contingency is hereby approved to bring the total project budget to \$3,609,753.00 and the Director of Public Works is hereby authorized to sign all change orders up to the authorized project budget amount.
3. The City Clerk is hereby authorized and directed to return forthwith to all bidders the bid bonds submitted with their bids, except the three lowest bidders. When a contract is duly executed, the bid bonds of the two remaining unsuccessful bidders will be returned. The bid bond of the successful bidder will be retained until the performance and payment bonds have been executed and approved, after which the bid bond will be returned.
