RECEIVE PETITION AND ORDER PUBLIC HEARING FOR VACATION OF DRAINAGE AND UTILITY EASEMENT FOR SECTION 1, MILL POND, VACATION NO. V19-06

The City received a petition dated June 3, 2019 from TEGL/AREP, LP, representing property owners abutting PID No.'s 01-31-23-13-0006 and 01-31-23-13-0005, requesting the vacation of utility and drainage easements located in Section 1, for the proposed plat of Mill Pond. The applicant represents a majority of the affected property abutting this easement.

WHEREAS, the City Council has received a petition dated the 3rd day of June 2019, requesting vacation of drainage and utility easement of Section 1, Mill Pond; and

WHEREAS, the Engineering Department has reviewed the petition and recommends that the City Council hold a Public Hearing on the requested vacation.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Blaine as follows:

1. The Council will consider the petitioned vacation of easements for the property owner.
2. A Public Hearing shall be held on the proposed vacation at 7:30 PM on the 5th day of August, 2019 and the City Clerk shall give mailed and published notice of such hearing and vacation as required by law.
