#### APPROVAL OF CLASSIFICATION AND SALE OF TAX FORFEIT PROPERTIES WITHIN THE CITY OF BLAINE

The Anoka County Board is commissioned by Statute to offer for sale tax forfeit properties in the County. The County Board approved Resolution No. 2019-117 on September 24, 2019, classifying certain tax forfeit lands in Anoka County, specifically eight parcels in Blaine.

Should the City desire to acquire any of these parcels of land, a request must be filed within sixty (60) days of the County's notification. The County Board will then withhold the parcel from sale for six (6) months. If the City fails to acquire the property within the withholding period, the County may offer it for sale upon expiration of the withholding period.

After review with the Engineering Department, the City is requesting that the following six parcels **be withheld** from public sale as they are parcels the City is interested in ownership for storm water related purposes:
