The city is requested to release specific lots from recorded development agreements on a fairly regular basis. In this instance, the developer of Lexington Meadows 2<sup>nd</sup> Addition has requested that the city release Lot 1, Block 1, Lexington Meadows 2<sup>nd</sup> Addition from the recorded development agreement of Lexington Meadows 2<sup>nd</sup> Addition. The lot in question is being purchased by Kwik Trip. All of the development agreement responsibilities for this lot have been met and the lot can be released. Kwik Trip will submit a Site Improvement Performance Agreement and financial guarantee to cover the cost of the site work specific to this lot prior to any work being performed on this site.

The City Council must adopt a resolution that authorizes the Mayor and City Clerk to execute the release.
