Approve 2022 Safety Services Capital Equipment Purchases

Executive Summary

The Safety Services Division is seeking approval to purchase the 2022 Capital Equipment items listed below.

Background

In the adoption of the 2022 Capital Budget, on December 20, 2021, Council appropriated funding for certain pieces of equipment in the Capital Equipment Plan. Pursuant to the City Charter, Sec. 6.05, staff is now requesting Council approval for the purchase of the items listed below. The items will be purchased from various vendors using the State Cooperative Purchasing Program. The unit cost prices below reflect prices from the state cooperative. Due to the ordering process for these items and to avoid delivery dates late into the year, it is necessary to make specific purchases as close to the beginning of the year as possible.
